

**THE FORM FOR THE COMMITMENTS TO BE OFFERED IN PRELIMINARY  
INQUIRIES AND INVESTIGATIONS CONCERNING AGREEMENTS,  
CONCERTED PRACTICES AND DECISIONS RESTRICTING COMPETITION,  
AND ABUSE OF DOMINANT POSITION (“COMMITMENT FORM”)**

*CJET submits the following commitments for the Board’s consideration.*

- 1. CJET competes with Mars and other distributors in the distribution market. CJET confirms that it has not engaged in any kind of coordination with Mars to display its movies in a more advantageous manner in movie theatres belonging to Mars. In order to reinforce the prevention of such coordination, CJET commits to maintaining this rival position with a structure that is operationally separate from Mars. CJET will not engage in any kind of coordination with Mars in the distribution market.*
- 2. CJET commits that it will maintain its structure, which is separate from Mars in terms of operational management, personnel and organization structure and that the executives working in CJET’s operational management will not be assigned in Mars simultaneously and an executive who is in charge of operational tasks will not be assigned in CJET simultaneously. Currently there are not any members of board of directors, executives or personnel at director level employed simultaneously in CJET and Mars. For the purposes of this commitment text, “operational management” means managing and directing daily work.*
- 3. CJET’s communication with Mars will be limited to the ordinary commercial relation, where CJET is distributor/producer; Mars is an exhibitor. Accordingly, the communication between CJET and Mars will take place within the framework of distributor/producer - exhibitor relationship. In line with this, the subject of the communication between CJET and MARS will be issues such as distribution of the productions distributed by CJET, their distribution in movie theatres, screening times, advertisement activities and performance evaluations. Within this scope, communication will not cover distribution activities of Mars or other competing distributors.*
- 4. Currently, CJET does not have access to Mars’s commercial secrets, competitively sensitive data or private database. With this commitment text,*

*CJET commits that Mars will not access its commercial secrets, competitively sensitive data or private database, similarly, CJET will not access Mars's commercial secrets, competitively sensitive data or private database.*

### **CONCLUSION**

*CJET believes that the commitments submitted will eliminate the competitive concerns in the Notification of Investigation. Within this framework, CJET commits to implementing the commitments in question within three months as of the notification of the reasoned decision, which accepts the commitments and to implementing those for three years.*

*In light of the explanations made above, CJET submits this form including its commitments for the consideration of the Competition Board to be evaluated per article 43(3) of the Competition Act and respectfully submits its request that the investigation process be terminated for your consideration.*
