Announcement of the Final Decision regarding the Investigation concerning Eight Ready-Mixed Concrete Firms active in Yozgat Province According to Article 49 of the Act no 4054 on the Protection of Competition

As a result of the investigation whether eight ready-mixed concrete firms active in Yozgat province violated article 4 of the Act no 4054 by means of price fixing and market allocation; considering all the evidence, information and documents collected, the Report prepared, the Additional Opinion, written defense and the explanations made during the oral hearing, the Competition Board took the following final decision numbered 20-15/215-107 in the meeting dated 19.03.2020.
